

## WESCO V.I.P. Pick Two Promotion Terms and Conditions

**Eligibility:** The WESCO V.I.P. "Pick Two" Promotion (the "Promotion") is open only to qualified electrical contractors who register with Philips Lighting North America Corporation and are located in and do business in the United States and Puerto Rico ("Qualified Electrical Contractors").
